COMPLAINT

I, the undersigned, state, on information and belief, that defendant did, in Del Norte Judicial District, County of Del Norte, State of California, commit the following crimes:

COUNT 1.

ASSAULT WITH A DEADLY WEAPON in violation of section PC245(a)(1), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in that Raoul Henri Domina Payette Jr did willfully and unlawfully commit an assault upon Jay McArthur with a deadly weapon, to wit, a semi-truck.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

COUNT 2.

ASSAULT WITH A DEADLY WEAPON in violation of section PC245(a)(1), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in that Raoul Henri Domina Payette Jr did willfully and unlawfully commit an assault upon Thomas Brock with a deadly weapon, to wit, a semi truck.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

COUNT 3.

ASSAULT WITH A DEADLY WEAPON in violation of section PC245(a)(1), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in that Raoul Henri Domina Payette Jr did willfully and unlawfully commit an assault upon Minette Bryant with a deadly weapon, to wit, a semi truck.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

COUNT 4.

ASSAULT WITH A DEADLY WEAPON in violation of section PC245(a)(1), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Assault With A Deadly Weapon in violation of PC245(a)(1), a Felony, was committed in that Raoul Henri Domina Payette Jr did willfully and unlawfully commit an assault upon Jessica Bungay with a deadly weapon, to wit, a power pole.

NOTICE: The above offense is a serious felony within the meaning of Penal Code Section 1192.7(c).

COUNT 5.

DEPOSITING HAZARDOUS SUBSTANCES in violation of section PC374.8(b), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Depositing Hazardous Substances in violation of PC374.8(b), a Felony, was committed in that Raoul Henri Domina Payette Jr, did knowingly cause a hazardous substance, to wit: asphalt oil, to be deposited upon a road, street, highway, alley, or railroad right-of-way, or upon the land of another without the permission of the owner, or into the waters of this state.

COUNT 6.

CARRY LOADED FIREARM IN PUBLIC PLACE, PERSON,VEHICLE in violation of section PC25850(c)(6), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Carrying a Loaded Firearm in Public in violation of PC25850(c)(6) was committed in that Raoul Henri Domina Payette Jr, did carry a loaded firearm in a vehicle while in any public place or on any public street in an incorporated city or in any public place or on any public street in a prohibited area of unincorporated territory when he was not listed with the Department of Justice pursuant to Section 11106 as the registered owner of the handgun.

COUNT 7.

HAVING A CONCEALED FIREARM IN A VEHICLE-NOT REGISTERED in violation of section PC25400(a)(1), a felony.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Having A Concealed Firearm In A Vehicle-Not Registered in violation of PC25400(a)(1), a Felony, was committed in that Raoul Henri Domina Payette Jr did unlawfully carry concealed within a vehicle which was under his control or direction a pistol, revolver or firearm capable of being concealed upon the person. It is further alleged, pursuant to Penal Code section 25400(c)(6) that the firearm was loaded, and the unexpended ammunition were in the immediate possession of, or readily accessible to, the defendant, Raoul Henri Domina Payette Jr and that the firearm was not registered to the defendant, Raoul Henri Domina Payette Jr.

COUNT 8.

HIT AND RUN DRIVING RESULTING IN PROPERTY DAMAGE in violation of section VC20002(a), a misdemeanor.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Hit And Run Driving Resulting In Property Damage in violation of VC20002(a), a Misdemeanor, was committed in that Raoul Henri Domina Payette Jr was driving a vehicle involved in an accident resulting in property damage and failed to immediately stop and either (1) locate and notify the owner or person in charge of the damaged property of his name and address and of the owner of the vehicle and present his driver's license and vehicle registration to the other driver, property owner or person in charge of that property; or (2) leave in a conspicuous place on the vehicle or property damaged a written notice giving his name and address and of the owner of the vehicle, along with a statement of the circumstances, and then notify law enforcement.

COUNT 9.

HIT AND RUN DRIVING RESULTING IN PROPERTY DAMAGE in violation of section VC20002(a), a misdemeanor.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Hit And Run Driving Resulting In Property Damage in violation of VC20002(a), a Misdemeanor, was committed in that Raoul Henri Domina Payette Jr was driving a vehicle involved in an accident resulting in property damage and failed to immediately stop and either (1) locate and notify the owner or person in charge of the damaged property of his name and address and of the owner of the vehicle and present his driver's license and vehicle registration to the other driver, property owner or person in charge of that property; or (2) leave in a conspicuous place on the vehicle or property damaged a written notice giving his name and address and of the owner of the vehicle, along with a statement of the circumstances, and then notify law enforcement.

COUNT 10.

DRIVING UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE in violation of section VC23152(a), a misdemeanor.

On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Driving Under The Influence Of An Alcoholic Beverage in violation of VC23152(a), a Misdemeanor, was committed in that Raoul Henri Domina Payette Jr did drive a vehicle while under the influence of an alcoholic beverage.

COUNT 11.

DRIVING WITH A .08% BLOOD ALCOHOL CONTENT in violation of section VC23152(b), a misdemeanor.


On or about April 28, 2022, in the County of Del Norte, State of California, the crime of Driving With A .08% Blood Alcohol Content in violation of VC23152(b), a Misdemeanor, was committed in that Raoul Henri Domina Payette Jr did drive a vehicle while having a 0.08 percent or more, by weight, of alcohol in his blood.

ENHANCEMENT

VC23578: Special Allegation- High Blood Alcohol

It is further alleged as to Count 10 and as to Count 11 that the defendant's concentration of blood alcohol was 0.15 percent by weight and more, within the meaning of Vehicle Code section 23578.
