Final determination regarding FPPC complaints regarding Political Reform Act

The Fair Political Practices Commission has officially and finally determined that complaints filed against Supervisors Gerry Hemmingsen, Chris Howard, Lori Cowan, and Bob Berkowitz, as well as County Administrative Officer Jay Sarina and Emergency Services Manager Kymmie Scott in relation to the Political Reform Act are without merit.

The FPPC Enforcement Division has further determined that actions taken by the County to inform voters did not violate the PRA that regulates such matters, and any and all allegations of legal inconsistency are in all actuality, false. As stated in the response letter(s) to complainants Donna Westfall and Linda Sutter (sworn complaint witnessed by Roger Gitlin and Wesley Nunn) the matter has been closed by the FPPC and no enforcement action will be pursued due to insufficient evidence.

After all complaints filed, were denied by the FPPC Enforcement Division, the Complainant then filed a request for reconsideration of the complaint with the Executive Director's Office of the FPPC. The request for reconsideration was reviewed and found to have no good cause that would direct the Chief of the Enforcement Division to reopen this matter. It was found that the mailers prepared by the County of Del Norte did not expressly advocate or unambiguously urge a particular result for or against Measure R as defined in the statute and regulations. Additionally, the Enforcement Division concluded that both the robocalls and the mailers were informational in nature and presented possible outcomes should Measure R be approved by the voters. The use of a consultant is not prohibited by the Act. Therefore, the request for reconsideration under Regulation 18360, subdivision (d) was denied and the matter will remain closed.

Dear Ms. Sutter:

This letter is in response to your request for reconsideration of the complaint against the above-named Del Norte County officials, collectively the "County of Del Norte". The complaint you filed in October 2020 alleged potential violations of the Political Reform Act (the "Act"), specifically the prohibition against campaign related communications sent at public expense. After a review of the initial complaint, Enforcement Division staff declined to open a case because they concluded that there was insufficient evidence of a violation of the Act.

You subsequently requested that the Enforcement Division revisit your request for an investigation. Your complaint alleges that the County of Del Norte violated the Act's prohibition on campaign related communications sent at public expense when it hired a consultant to assist on the Measure R messaging, disseminated robocalls to voters regarding Measure R, and distributed mailers to voters regarding Measure R.

Your request for reconsideration has been reviewed and there is no good cause to direct the Chief of the Enforcement Division to reopen this matter. The mailers prepared by the County of Del Norte do not expressly advocate or unambiguously urge a particular result for or against Measure R as that is defined in the statute and regulations. Additionally, the Enforcement Division concluded that both the robocalls and the mailers were informational in nature and presented possible outcomes should Measure R be approved by the voters. The use of a consultant is not prohibited by the Act.

Therefore, your request for reconsideration under Regulation 18360, subdivision (d) is denied.

Mass Mailing. More than 200 substantially similar items are sent in a calendar month, excluding any item sent in response to an unsolicited request.

Additionally, the copy of the contract that demonstrated the cost of the mass mailings you determined was not relevant because it fell under "educational literature?" Apparently, Howard Jarvis Tax Association agreed with me along with the Secretary of State that this was in violation of 89001. So I humbly ask if you could direct me to the portion of law that describes the educational mass mailings using public funds is appropriate.

Re: Reconsideration of Sworn Complaint Against Sarina, Scott, Hemmingsen, Cowan, Howard, Berkowitz (COM-10282020-02957)

Dear Ms. Sutter:

This letter is in response to your request for reconsideration of the complaint against the above-named Del Norte County officials, collectively the "County of Del Norte". The complaint you filed in October 2020 alleged potential violations of the Political Reform Act (the "Act"), specifically the prohibition against campaign related communications sent at public expense. After a review of the initial complaint, Enforcement Division staff declined to open a case because they concluded that there was insufficient evidence of a violation of the Act.

You subsequently requested that the Enforcement Division revisit your request for an investigation. Your complaint alleges that the County of Del Norte violated the Act's prohibition on campaign related communications sent at public expense when it hired a consultant to assist on the Measure R messaging, disseminated robocalls to voters regarding Measure R, and distributed mailers to voters regarding Measure R.

Your request for reconsideration has been reviewed and there is no good cause to direct the Chief of the Enforcement Division to reopen this matter. The mailers prepared by the County of Del Norte do not expressly advocate or unambiguously urge a particular result for or against Measure R as that is defined in the statute and regulations. Additionally, the Enforcement Division concluded that both the robocalls and the mailers were informational in nature and presented possible outcomes should Measure R be approved by the voters. The use of a consultant is not prohibited by the Act.

Therefore, your request for reconsideration under Regulation 18360, subdivision (d) is denied.

This letter is in response to the sworn complaint you submitted to the Enforcement Division of the Fair Political Practices Commission regarding the above-referenced individuals. The Enforcement Division will not open an investigation on this matter.

The Commission enforces the provisions of the Political Reform Act¹ (the "Act"). Based on a review of the complaint and the documented obtained, the Enforcement Division found insufficient evidence of a violation of the Act.

The Act prohibits sending a newsletter or other mass mailing at public expense.² After review of the complaint, we found that the robocall and mass mailings concerning the County of Del Norte Measure R were informational in nature and did not expressly advocate for or against the measure, nor unambiguously urge a result in the upcoming election. Given the above, the Enforcement Division cannot conclude that the mailers in question violated the Act's prohibition against campaign mailers sent at public expense. Additionally, we have insufficient evidence to substantiate the allegation that the County was required to file as a committee regarding their activity with Measure R. Therefore, we are closing this matter and will not pursue an enforcement action.

The Commission provides advice and opinions to persons whose duties are in question under the Act. (Section 83114.) In the future, if the County of Del Norte has questions regarding the Act's mass mailing sent at public expense prohibitions, the County may request formal advice by submitting an inquiry to the FPPC's Legal Division. Please note that a formal advice letter can provide the requestor immunity from enforcement actions by the FPPC.
