

I, the undersigned, state, on information and belief, that defendant did, in Del Norte Judicial District, County of Del Norte, State of California, commit the following crimes:

#### COUNT 1.

# PERJURY BY DECLARATION in violation of Penal Code section 118(a), a felony.

On or about February 8, 2022, the defendant did unlawfully, under penalty of perjury, declare as true that which was known to be false, to wit: the defendant listed his address as 16855 US Highway 101 N #2, Smith River, California, 95531 on his California Voter Registration form.

# FALSE VOTER REGISTRATION in violation of Elections Code section 18100(a), a felony.

On or about February 8, 2022, the defendant did unlawfully register to vote in Del Norte County,

knowing that he is not entitled to registration.

## FALSE DECLARATION OF CANDIDACY in violation of Elections Code section 18203, a felony. On or about February 14, 2022, the defendant did unlawfully file or submit for filing a nomination paper

or declaration of candidacy knowing that any part of it was made falsely, to wit: the defendant stated he meets the statutory and residency requirements to run for the office of Sheriff of Del Norte County.
