BRIEF BACKGROUND:

430.640 Duties of Oregon Health Authority in assisting and supervising community mental health programs; rules.

- (1) The Oregon Health Authority, in carrying out the legislative policy declared in ORS 430.610, subject to the availability of funds, shall:
- (a) Assist Oregon counties and groups of Oregon counties in the establishment and financing of community mental health programs operated or contracted for by one or more counties.
- (b) If a county declines to operate or contract for a community mental health program, contract with another public agency or private corporation to provide the program. The county must be provided with an opportunity to review and comment.

Oregon Health Authority interprets statutes as follows: (OHA) contracts with the Local Mental Health Authority (LMHA) to either provide the services of the Community Mental Health Provider (CMHP) or subcontracts for the services of the CMHP.

If the LMHA is unable to do above, the option is to return the LMHA to OHA. With new Curry Mental Health issues surfacing, there is urgency for our County to responsibly act in the best interest of our Citizens; It is imperative that we promptly relinquish-transfer our LMHA to OHA. They will then become responsible for selecting an LMHA. We have been working very closely with OHA staff, the Community Care Organizations, and Adapt in regards to transitioning the responsibilities of the CMHP. By relinquishing the LMHA, we can then encourage and enable Adapt Health Care of Douglas County, or whomever the state selects, to Contract directly with OHA for important Curry County Mental Health Services.

This will also assist the new LMHA/CMHP to immediately work to recruit our current Curry Community Health employees that if they so choose to remain in our local communities.

Adapt Oregon is willing to take on the CMHP role, but cannot contract directly with Curry County and can only contract with the Community Care Organizations – Advanced and All Care Health. Court Boice is asking the Curry County Board of Commissioners to act promptly in responsibly transferring the Local Mental Health Authority (LMHA) to Oregon Health Authority (OHA).
