WHEREAS; ORS 431.170 directs the Oregon Health Authority (OHA) to take direct charge of the functions that are necessary to preserve the public health in a Local Public Health Authority whenever a local public health administrator fails to administer or enforce ORS 431.01 (findings) to 431.550 (Power of Oregon Health Authority to collect information from local public health administrators) and 431.990 (penalties) and any other public health law or rule of this state as described in ORS 431.150 (enforcement of public health laws generally); and

**WHEREAS**; ORS 431.382 allows a governing body of a Local Public Health Authority to transfer authority to OHA if the county cannot fulfill its obligations under law or contract for public health services and activities within its jurisdiction; and

WHEREAS, The 2018 Public Health Modernization: Report to Legislative Fiscal Office stated that an additional \$47.7M was needed to support the 2019-21 biennium. The Oregon Legislature only allocated an additional \$10M for public health modernization in the 2019-21 biennium; and

WHEREAS; Curry County Board of Commissioners received an email (letter) from OHA dated April 8, 2021, indicating the intent to take direct charge of the public heath functions in Curry County necessary to preserve public health, which includes all communicable disease and Covid-19 response work, all Covid-19 vaccination efforts, and all environmental health services work, should the county not provide necessary documentation to the OHA that the county is fulfilling its obligations; and

**WHEREAS**, the Local Public Health Authority in Curry County currently has a staff of one (1), which is the Public Health Administrator; and

WHEREAS; on April 16, 2021 the Curry County Board of Commissioners voted to transfer its Local Public Health Authority, ORS 431.382, over to OHA; and

Now therefore, the board of curry county commissioners

HEREBY RESOLVES TO transfer all Local Public Health Authority duties to the Oregon

Health Authority to not take effect until 180 days after date on resolution mandating the

transfer is adopted unless the Oregon Health Authority agrees to an earlier effective date.

#### 1. CALL TO ORDER & PLEDGE OF ALLEGIANCE

The meeting was called to order by Chair Boice at 11:30 a.m. Present were Chair Court Boice, Vice Chair John Herzog, and Commissioner Chris Paasch.

Also present: Legal Counsel Anthony Pope and Administrative Assistant John Jezuit

Absent: Director of County Operations Brad Rueckert

The Pledge was recited by all.

#### 2. APPROVAL/AMENDMENT OF THE AGENDA

Motion by Herzog, seconded by Paasch, to approve agenda as written. Motion carried unanimously.

#### 3. PUBLIC COMMENT

Michelle Martin disagreed with the transfer and encouraged the Board to have a workshop regarding mental health. Nancy Sue Rose hopes questions will be answered and noted mental health needs of people here. Captain Phil McDonald strongly disagrees with the decision to transfer mental health, observed the Sheriff's department interacts more with mental health than any other agency in the County, and advised the Board not to give up control of mental health. Janell Howard expressed concern about giving up local control, and stated she is disappointed if CCH (Curry Community Health) will step up to the plate only if the Board gives up local control. Brad Alcorn stated it is important for law enforcement to have a place to take people who need help. Pope stated, by statute, the four (4) year time frame applies to Public Health, not Mental Health.

The Commissioners responded to the Public Comments. Boice read the CCH letter, noted the County has a good opportunity here, said this is a temporary deal, and observed CCH has some hard feelings. Herzog stated timing is big as the County does not want to lose any services, observed keeping the 24/7 services we have now is critical, and noted this is a win-win. Paasch commented on this decision, specifically, he (1) noted it is a shame to have such a short period of time to make the decision, (2) suggested a workshop with all effected parties to discuss this issue, and (3) urged the Board to be very careful.

#### 4. DISCUSSION

A. Curry County – Transfer Curry Local Mental Health Authority to the Oregon Health Authority - Resolution - Commissioner Boice

Boice read the resolution. A lengthy discussion with Barnes, Judge Cynthia Beaman, Boice, Herzog, Martin, Capt. McDonald, Paasch, and Pope about the impact of this decision on the County followed. Paasch asked about all the inventory, real estate, and money the county gave to CCH and stated Ginny Williams, CEO of CHN (Curry Health Network) could provide services. Herzog stated CCH is best option for County right now and emphasized services cannot change. Boice spoke about building a relationship with CCH and possibly forming a task force. Judge Beaman emphasized communications with the County and citizens need to be better because people are confused about what is going on, noted it is helpful to have more than one (1) provider, observed there is not time for a workshop, and encouraged the Board to come up with a comprehensive plan and multiple providers. Barnes, speaking as a public citizen, urged the Board not to give County stuff away. Martin asked about what is going to happen in September 2021 and recommended a workshop.

Motion by Herzog, seconded by Boice, to relinquish local mental health authority back to the Oregon Health Authority, OHA, State of Oregon. Motion carried 2-1 (Boice – Yes; Herzog – Yes; Paasch – No)

## Duties of governing bodies of local public health authorities

- · fee schedules
- (1) Subject to the availability of funds paid pursuant to ORS 431.380 (Distribution of funds), each governing body of a local public health authority shall:
  - (a) In collaboration with the local public health administrator appointed under ORS 431.418 (Local public health administrator), develop public health policies and goals for the local public health authority;
  - (b) Adopt ordinances and rules necessary for the local public health authority to administer ORS 431.001 (Findings) to 431.550 (Power of Oregon Health Authority to collect information from local public health administrators) and 431.990 (Penalties), any other public health law of this state and any other public health matter not expressly preempted by a law of this state;
  - (c) Adopt civil penalties for violations of ordinances and rules adopted under paragraph (b) of this subsection, provided that any civil penalty adopted under this paragraph is for an amount that does not exceed \$1,000 per violation per day;
  - (d) Review and make recommendations on the local public health modernization plan adopted under ORS 431.413 (Powers and duties of local public health authorities); and
  - (e) Monitor the progress of the local public health authority in meeting statewide and local public health goals, including progress in applying the foundational capabilities established under ORS 431.131 (Foundational capabilities) and implementing the foundational programs established under ORS 431.141 (Foundational programs).
- (2) The governing body of a local public health authority shall adopt ordinances and rules necessary to carry out the duties of the local public health authority under subsection (1) of this section. The governing body of a local public health authority may not adopt an ordinance or rule or policy that is inconsistent with or less strict than a provision of ORS 431.001 (Findings) to 431.550 (Power of Oregon Health Authority to collect information from local public health administrators) and 431.990 (Penalties) or any other public health law of this state, or that is inconsistent with or less strict than a rule adopted under ORS 431.001 (Findings) to 431.550 (Power of Oregon Health Authority to collect information from local public health administrators) and 431.990 (Penalties) or any other public health law of this state.
- (3) The governing body of a local public health authority may adopt schedules of fees for public health services that are reasonably calculated to not exceed the cost of the services performed. The local health department shall charge fees in accordance with the schedule

# ORS 431.417 Distribution of moneys to local public health authorities

- rules
- (1) The Oregon Health Authority may by rule require each local public health authority to submit a plan, in a form and manner prescribed by the Oregon Health Authority, that describes how the local public health authority will use moneys made available under ORS 431.380 (Distribution of funds).
- (2) The Oregon Health Authority may enter into an agreement with each local public health authority that describes the work the local public health authority agrees to perform and the amount of state funding the local public health authority will receive under ORS 431.380 (Distribution of funds).
- (3) The Oregon Health Authority may enter into one or more agreements with a local public health authority for purposes of distributing funds, or providing incentives, to the local public health authority that are available through federal grants or other sources. Before entering into an agreement under this section, the Oregon Health Authority shall adopt by rule a process by which a local public health authority must submit the documentation necessary to receive incentives under an agreement authorized by this subsection. ## ORS 431.418 Local public health administrator

- health officer
- duties
- salary
- (1) Except when a local public health authority has transferred its responsibility to the Oregon Health Authority under ORS 431.382 (Transfer of local public health authority's responsibility), a local public health authority shall appoint a qualified local public health administrator to supervise the activities of the local public health authority. In making an appointment under this subsection, the local public health authority shall consider standards for selection of local public health administrators prescribed by the Oregon Health Authority.
- (2) Intentionally left blank —Ed.
  - (a) When the local public health administrator is a physician licensed under ORS chapter 677, the local public health administrator may serve as the local health officer for the local public health authority.
  - (b) When the local public health administrator does not serve as the local health officer, the local public health administrator shall employ or otherwise contract for services with a local health officer who is a physician licensed under ORS chapter 677 to perform the specific medical responsibilities requiring the services of a physician.
  - (c) A physician employed or whose services are contracted for under this subsection is responsible to the local public health administrator for the medical and paramedical aspects of the public health programs administered by the local public health administrator.
- (3) The local public health administrator shall:
  - (a) Serve as the executive secretary of the local public health authority, act as the administrator of the local health department and supervise the officers and employees appointed under paragraph (b) of this subsection.
  - (b) Appoint, subject to the approval of the local public health authority, administrators, medical officers, public health nurses, environmental health specialists and such employees necessary to carry out the duties of the local public health administrator under ORS 431.001 (Findings) to 431.550 (Power of Oregon Health Authority to collect information from local public health administrators) and 431.990 (Penalties) and any other public health law of this state.
  - (c) Provide the local public health authority at appropriate intervals information concerning the activities of the local health department and submit an annual budget for the approval of the governing body of the county or, for a health district formed under ORS

- and rules of the authority, including such sanitary inspection of hospitals and related institutions as may be requested by the authority.
- (e) Perform any other duty required by law.
- (4) A local public health administrator shall serve until removed by the appointing local public health authority. A local public health administrator may not engage in an occupation that conflicts with the local public health administrator's official duties and shall devote sufficient time to fulfilling the requirements of subsection (3) of this section. However, if the governing body of a local public health authority is not established under ORS 431.443 (Formation of health districts) (3), the local public health authority may, with the approval of the Director of the Oregon Health Authority, require the local public health administrator to work less than full-time.
- (5) A local public health administrator shall receive a salary fixed by the appointing authority and shall be reimbursed for actual and necessary expenses incurred in the performance of duties. # ORS 431.510 Facilities and funds for local public health authorities

- (1) The governing body of a county shall provide adequate quarters and facilities for the office and operations of a local public health authority and shall appropriate sufficient moneys for the administration of the local public health authority and the operation of the local health department administered by the local public health authority.
- (2) If a health district is established under ORS 431.443 (Formation of health districts), the governing body of each participating county shall appropriate annually moneys specifically designated for the administration of a local public health authority described in ORS 431.443 (Formation of health districts) (2) or established under ORS 431.443 (Formation of health districts) (3) and the operation of the local health department administered by the local public health authority.
